Working on behalf of more than 500 individuals in Eastern Kentucky, she successfully resolved claims arising from an October 2000 coal sludge disaster. Paulina also served as lead pro bono counsel on behalf of seven victims and their decedents in hearings before the September 11th Victim Compensation Fund arising out of the 2001 terrorist attacks on the World Trade Center in New York City. The combined awards obtained were in excess of \$5 million.
